However, the very fact of disclosing these contradictions and trends is a positive element in the system of scientific logic, since scientific substantiation and the search for solutions to the indicated problems is a potential: progress (both by the forces of the presented work and by a contribution to science as a whole). Following its own path of renewal and progress, our country joined this global concept, defining the socially oriented nature of the legal and social protection of a person, shaping his spiritual and moral formation. In order to implement these ideas, various legal institutions have been created in the republic in recent years: the Ombudsman Institute, the National Center for Human Rights of the Republic of Uzbekistan, the Institute for Monitoring Current Legislation, the Center for the Promotion of Legal Education, the Center for the Study of Human Rights, the Center for the Study of Public Opinion, as well as a number of NGOs of the corresponding profile.

Currently, there are more than ten women's public organizations in Tashkent and more than 50 nationwide, the women's movement is expanding. Many international legal documents and information on the activities of the international women's movement and non-governmental women's organizations became known to the general public only after the approval of the independence of the Republic of Uzbekistan.

The republic was one of the first in Central Asia to join the UN Convention "On the Elimination of All Forms of Discrimination against Women", which confirms the rights of women and determines the action plan of states to protect them. The same task was formulated as one of the main ones at the Fourth World Conference of Women (PRC, Beijing, September 1995), which was held under the motto "Action for Equality, Development, Peace". Of fundamental importance for understanding women's rights is the fact that generally recognized principles and norms of international law are an integral part of the legal system of our society. In this regard, the last Decree of the President of the Republic of Uzbekistan "On additional measures to support the activities of the Women's Committee of Uzbekistan" dated May 25, 2004 and the adopted Resolution of the Cabinet of Ministers on the program of measures to ensure the implementation of this decree should be noted.³

All these facts are vivid evidence of the social activity of people, social groups and Uzbek society as a whole, the manifestation of which has become truly possible in the context of democratic and structural transformations in Uzbekistan. However, having examined specifically the historical stage of social development in the stage of transition in the country, the dissertation provides a scientific analysis taking into account the well-known paradigm of social development, according to which development is a process of irreversible changes that lead to the emergence of a new quality, a new system in which we are now chronologically dwell. In this regard, the dissertation affirms the idea that today a new generation has emerged, a new social institution "social activity" has established itself, historical epoch-making signs have affirmed the female part of the population in its new quality: as the most active and socially mobile part of society. In this regard, not only progress is natural, but also the achievement of a new level by society. However, the logic of the development of society is such that progress in only one direction will inevitably lead to a regression of the entire social system. Hypothetically, it can be assumed that the salvation of humanity here lies in the following: giving to its development stability, coherence between nature and society, between the past, present and future; creating a high-quality mechanism of intergenerational continuity, finding the optimum in achieving superproductive indicators, mobilizing the potential of society, including the social activity of people, groups (women). In this regard, the dissertation student analyzes many gender problems: the policy of equal opportunities for men and women, discrimination in employment, wages, promotion; distribution of social roles of employees with family responsibilities; declining fertility; tracking socio-demographic indicators of fertility, living standards, child mortality, health potential of women, compared with men, contradictory trends in female development. For the purpose of scientific reliability, a wide factual was used: illustration of statistical indicators for demographic and sociological data, mathematical calculations, as well as methods of mathematical modeling.

Solving the problem of women's interest in entrepreneurship, today ways and measures have been developed to improve this area, subject to the provision of support by state and non-state structures. Their grouping is also presented in this section. A progressive trend in the development of modern women's governmental and non-governmental organizations is the fact that their activities are expanding not only at the national but also at the international level. It should be mentioned that over the past 25 years at international conferences fruitful work has been going on to change the status of women in politics, economics, and public consciousness. Under the auspices of UNDP and the Women's Committee, various development programs are being implemented in the Republic to improve the status of women, create equal rights and opportunities, as well as increase self-awareness and social activity. Things have come to the point that recently the discourse about the onset of the "era of women" has been actualized. To answer the question about the role, place, status, activity, sufficiency of the latter, we made an attempt to logically model this phenomenon.

It is advisable to use state private enterprise mechanisms to support agricultural producers. Lease financing is an effective tool for increasing the competitiveness of agricultural producers. The competitiveness of domestic agricultural producers is largely determined by their technical equipmen t. the process of sustainability, as well as factors of socialization and social status, determined by gender. The task was realized by the methods of mathematical modeling.

Having considered over 70 social indicators, we classified groups according to biological, social and psychological factors, which, in fact, represent the social status of women. When assessing the degree of significance of these factors, their nature and the role of each factor in the formation of the phenomenon under consideration were taken into account. For example, to assess a group of factors of women's social activity, 5 approaches have been identified: systemic, functional, statistical, basic, and role-based. In addition, the dynamics and evolution of the social processes under consideration can be described by highlighting various aspects of indicators: declared, desired, setting, as well as by introducing estimates of the distributions of factor values for different points in time.
